- For events organised by AFA affiliated clubs or members which provide training and/or one-on-one training for participants but have a restricted number of participants even though open for all AFA members the use charges are negotiated and then set by the

AFA on event approval. Or for Special Events where the AFA or AFA members are involved which promotes the flyball as a sport.

The AFA will not hire its equipment to other organisations if there is no involvement of the AFA and/or its members.

It was agreed that a Rule Clarification Notification would be issued to advise members of charges. The rewrite of the Policy document would be done as part of the Rules Update but the new charges would be included on the web under fees asap. Use fees to be reviewed annually at time of normal fees review.

iii) Dog age for racing lifted to 18 months.

The Sub Committee confirmed that only two minor changes were required to Rules to reflect the decision at AGM to lift age for racing to 18 months and both changes had already been made and included in the latest Rules on web.

iv). Training of dogs under 18 Months.

The Sub Committee considered if any changes were required to current Rules and conclude that current wording was appropriate as they limited dogs to training over jumps and turning on box from 12 months of age at AFA training days. Club training rules were seen as a matter for Clubs to monitor.

David also reported on the Meeting to consider the matter of Multi- Venue Competitions. The recommendation was to conduct a Mock Competition at two separate venues to see what problems emerged under the Rules. ACT and Tassie had agreed to be part of Mock comp – Sanction was to be sought shortly. This would allow Rules to be tested and ant problems identified.

Ben advised that Landing Page was still not finalized – expected that to be done by February. Pat reported on a request for statistical information – it was agreed that a Data Dump should be done by Pat and sent to Sub Committee with member specific info deleted.
