

AFA Policy on the Authority to Alter Entries and Sanction Details

1 January 2024

POLICY ON DELEGATED AUTHORITY TO ALTER ENTRIES AND CHANGES TO SANCTIONS

Purpose

The **AFA committee** frequently receives requests from:

- *clubs* to approve entry of *teams* to a *race meeting* after the *close of entry date*;
- clubs to approve changes to their teams' entries;
- *host clubs* to approve changes to sanctioned details of *race meetings*.

This policy has been developed to provide clarity and guidance for *clubs* on:

- what changes the **AFA committee** is willing to consider approving;
- who has the authority to approve changes; and
- responsibilities of *host clubs* when changes are approved.

Definitions and Interpretation

In this policy:

- words and expressions which are defined in the *rules* have the same meaning when used in this policy;
- the principles of interpretation contained in the *rules* apply.

Late entries

The *rules* define the *close of entry date* as the last day for receipt of entries for a *race meeting*.

The **AFA committee** considers it would be unfair to **teams** that have entered a **race meeting** by the **close of entry date** to allow **clubs** to enter **teams** after the **close of entry date**.

The **AFA** committee will not approve requests to enter a **team** after the **close of entry date**.

Changes to entries

The *rules* permit *teams* to change specific details on *timesheets* before the start of a *race meeting* but do not contemplate other changes.

The **AFA committee** considers other changes, including changes to **seed times**, are not fair to other **teams**.

The **AFA committee** will not approve changes to entries other than those expressly allowed under the **rules**.

Changes to race meeting details

The **AFA committee**:

- acknowledges that from time to time **host clubs** may request approval to change sanctioned details of a **race meeting**;
- has determined that not all requests need to be considered by the full **AFA committee**.

The table below shows the changes for which a **host club** may request approval and who has delegated authority to grant or refuse each request.

Notice to clubs

When any of the changes marked "*" are approved the *host club* must:

- promptly notify all *clubs* who have entered *teams*;
- allow those *clubs* to withdraw, or submit an amended entry for, any *team* entered by them.

If a *team* is withdrawn the *host club* must refund the entry fee paid for the *team*.
